CHECK I understand Red Rock Valley Limited Privacy Policy

Red Rock Valley Limited. (“RRVLT”) operates several websites including www.childrentalk.com. It is Red Rock Valley Limited’s policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, Red Rock Valley Limited collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Red Rock Valley Limited’s purpose in collecting non-personally identifying information is to better understand how Red Rock Valley Limited’s visitors use its website. From time to time, Red Rock Valley Limited may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Red Rock Valley Limited also collects potentially personally-identifying information like Internet Protocol (IP) addresses. Red Rock Valley Limited does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances that it uses and discloses personally-identifying information, as described below.

Gathering of Personal Identification and Information

Certain visitors to Red Rock Valley Limited’s websites choose to interact with Red Rock Valley Limited in ways that require Red Rock Valley Limited to gather personally-identifying information. The amount and type of information that Red Rock Valley Limited gathers depends on the nature of the interaction. For example, we ask visitors who would like to contact us to enter in their contact information, or to contact them for prize, authorship, authenticity verification and so on. Those who engage in transactions with Red Rock Valley Limited – by purchasing our products and services, or uploading videos and comments to our site, for example – are asked to provide additional information, including as necessary the personal and payment information required to process those transactions. In each case, Red Rock Valley Limited collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor’s interaction with Red Rock Valley Limited. Red Rock Valley Limited does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities, such as uploading information. All information uploaded to our site is held in our archives and only if determined suitable by our staff, may or may not be used on our broadcasts or internet media.

Aggregated Statistics

Red Rock Valley Limited may collect statistics about the behavior of visitors to its websites. For instance, Red Rock Valley Limited may monitor the site or use spam screened by it’s service to help identify spam. Red Rock Valley Limited may display this information publicly or provide it to others. However, Red Rock Valley Limited does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Red Rock Valley Limited discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know

that information in order to process it on Red Rock Valley Limited's behalf (such as ecommerce transactions for purchasing items in our store) or to provide services available at Red Rock Valley Limited's websites (such as reviewing ShortKuts) and , (ii) have agreed not to disclose it to others. None of those employees, contractors and affiliated organizations are located outside the United States, and we don't use offshore development. By using Red Rock Valley Limited's websites, you consent to the transfer of such information to them. Red Rock Valley Limited will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Red Rock Valley Limited discloses potentially personally-identifying and personally-identifying information only when required to do so by law, or when Red Rock Valley Limited believes in good faith that disclosure is reasonably necessary to protect the property or rights of Red Rock Valley Limited, third parties or the public at large. If you are a registered user of a Red Rock Valley Limited website and have supplied your email address, Red Rock Valley Limited may occasionally send you an email through our RSS feed or other opt in service to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Red Rock Valley Limited and our products, such as Children Talk. We primarily use our news page and our FAQ to communicate this type of information, so we expect to keep communication and email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Red Rock Valley Limited takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Red Rock Valley Limited uses cookies to help Red Rock Valley Limited identify and track visitors, their usage of Red Rock Valley Limited website, and their website access preferences. Red Rock Valley Limited visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Red Rock Valley Limited's websites, with the drawback that certain features of Red Rock Valley Limited's websites may not function properly without the aid of cookies.

Ads

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Red Rock Valley Limited and does not cover the use of cookies by any advertisers.

Comments

Comments and other content submitted to our comments area are not saved on our servers unless they were marked as false positives, in which case we store them long enough to use them to improve the service to avoid future false positives.

CHECK I understand the Media Release Waiver

For good and valuable consideration the receipt and adequacy of which is hereby acknowledged, the undersigned grant(s) Children Talk and its affiliates, licenses and assigns (collectively, the "Licensee"): (a) the irrevocable right and license to use mine and/or my child's name and film, photograph and otherwise visually or audio-visually record my child's picture, likeness, voice, conversations, sounds and performances in and in connection with the Project and (b) all rights of every kind and character (including copyrights) in and to the results and proceeds of mine and/or my child's appearance in the Project, including, without limitation, all film, photographs and video and audio recordings produced by Licensee in connection therewith and any and all performances, stories, statements or actions made by my child, whether written, spoken, sung, or otherwise uttered or expressed by him/her, or information given by me and/or my child, captured on any such recordings (collectively the "Production Material").

I/We acknowledge that Licensee shall be the exclusive owner(s) of the Project and all Production Material and have the irrevocable right, in perpetuity throughout the universe, in any and all languages, in any and all media know known or hereafter invented, and without requirement for the payment of any royalties or other compensation, to: (a) exhibit, broadcast, use, reproduce and license others to use as they see fit all or any part of the Production Material; (b) edit, dub, subtract from, add to or modify the Production Material in any manner, combine it with any other material and/or incorporate it into other films, projects or programs; and (c) use and license others to use me and/or my child's name, voice, likeness, image, photograph, performance, participation, expressions, personal experiences and biographical material in and in connection with the production, distribution, advertising, publicity, promotion, exhibition and other exploitation of the Production Material and/or any portion thereof, and in connection with Licensee's products and services, an unlimited number of times.
